Judge Norman Thorne QC also said he was "satisfied" the case against Robert Thompson could go ahead. Venables was 15 when he strangled and dismembered two-year-old James Bulger in 1993. Thompson, now 39, was convicted at the same trial of conspiracy to murder and was sentenced to life. Bulger was snatched from a Birmingham shopping centre by two young men. He was seen by a woman, who described them as "kidnappers". She phoned the police, who found him minutes later in a yard not far from the Black Country's Bostock Road. Bulger's body was eventually found dumped in a field on the outskirts of Liverpool. The case against Thompson received a fresh trial in 2008 and a jury took just 40 minutes to find him guilty. But the House of Lords later quashed the verdicts, ruling that a new trial was necessary. Lawyers representing Bulger's family have been pressing for a fresh trial and Judge Thorne said he was satisfied the case against Thompson could go ahead. The judge said there was a "real prospect" the former care home worker from Liverpool would face a retrial, adding that the prosecuting authorities had made a "positive c6a93da74d
